



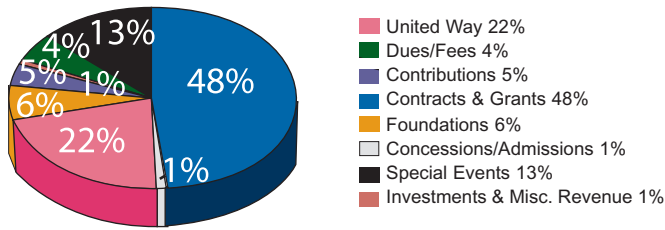

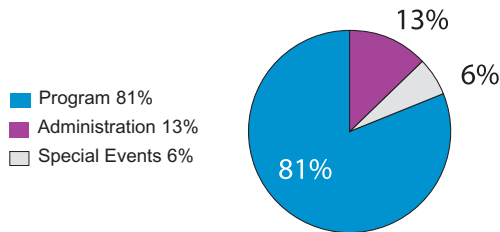

## Total Income \$1,385,114

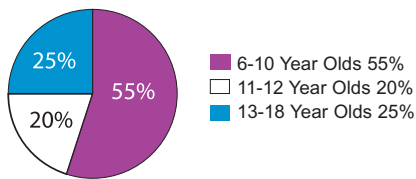


## Total Expenditures \$1,116,986

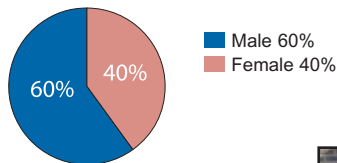


## Total Club Members - 1451

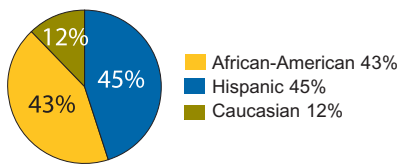
### Membership by Age



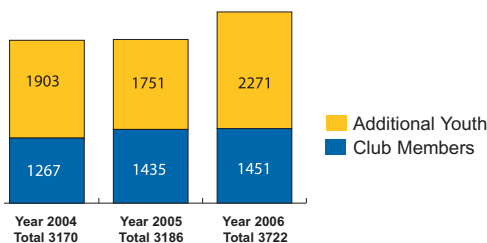
### Membership by Gender

Membership is only \$25 for an entire school year of programs which cost us \$550 to provide.
