

## HALL COUNTY

Boys & Girls Clubs of Lanier, originally the Gainesville-Hall County Boys Club, was established in 1954 on Sycamore Street (now EE Butler Parkway). Our flagship Positive Place Club and 14 additional Club sites call Hall County home, serving kids in grades K-12.

## HABERSHAM COUNTY

Boys & Girls Clubs of Lanier's Tim Lee Club, the first Club in Habersham County, was established in June of 2021. In addition to the Tim Lee Club, the organization hosts programs in the county's elementary schools, serving kids in grades K-8.

## FORSYTH COUNTY

Boys & Girls Clubs of Lanier's new Tommy & Chantal Bagwell Club continues to make progress, with plans to open in early 2024 and serve 300+ kids in grades K-12.

### Member Emotional Social Health (MESH)

The purpose of the MESH program is to promote positive social and emotional skills development, address mental health needs, and mitigate the effects of toxic stress and childhood trauma. In 2022, BGCL hired social worker **Keo Copeland** to manage the MESH program. Since piloting the program, Ms. Copeland has been able to work with members in individual and group settings to help them learn new coping strategies, giving them the tools they need to be successful and happy. We are grateful for Hall County Government and United Way of Hall County for partnering with us to address the social emotional health of local youth.

### **Meet Jaiyah**

At 8 years old, Jaiyah Stringer was enrolled at Boys & Girls Clubs of Lanier and has been a loval member since. Jaiyah's journey has not been easy, but she has overcome so many obstacles to become who she is today. Coming from a single-parent household, Jaiyah was very timid when she first joined the Club. It was through interactions with staff members that she realized she was welcome and free to express herself. But her battle did not end there. Through her early teen years, Jaiyah faced severe anxiety, depression, and thoughts of suicide. She faced bullving and always felt as if she were not good enough. The Club gave her a place to come where she felt safe and acknowledged. Because of her community at Boys & Girls Clubs of Lanier and staff members. Derrick Caldwell and Gabe Copeland, Jaivah did not have to face this battle alone.

Jaiyah will be graduating in 2023. Because of her journey, Jaiyah is an advocate for mental health and plans to attend Fort Valley State University and study to become a social worker. She hopes to return to her Gainesville community and make an impact on young people, just as she was impacted by Boys & Girls Clubs of Lanier.
